This practice gives the participants self confidence while communicating with others, cooperating and developing problem-solving skills; 2. It offers participants the opportunity to experience creative methods in order to find solutions for given problems; 3. The practice allows the organizers to bring together people with diverse backgrounds (abilities, culture, education etc.). This could be a mean to promote social inclusion; 4. The practice does not require other resources than people and ideas. The content can be easily adapted to the organization/target group of the organization; 5. It is an appropriate method for young people who might not be otherwise open to discuss such serious issues. 	<p>WEAKNESSES</p> <ol style="list-style-type: none"> 1. Some participants might not be able to find themselves and their issues in the presentation/scenario; 2. Some participants might not perceive immediat benefits so they would not be very participative/motivated; 3. The method does not approach directly social inclusion issues; 4. Not everybody will be comfortable with some of the issues approached in group discussions, especially where they all know eachother; 5.
